Gertrude Kistler Memorial Library (GKML) will provide digital photo duplication services for most materials from the collection. All requests are subject to the following conditions:

- Physical condition of the item
- Donor-imposed restrictions
- Copyright imposed restrictions
- Limited staff time and resources
- Terms and Conditions are met (*please see below*)

Requesters are expected to abide by all copyright laws. Reproductions are provided for research use only and may not be transferred, published, or exhibited without obtaining legally required permission from Rosemont College or the copyright owner.

Internal College Use

Circulating Collection

Rosemont College abides by all copyright restrictions. GKML will not fully copy protected work to be used in publications or for educational purposes. The library can provide scans of selected pages or a chapter of a work, not exceeding 10% of the work for classroom purposes.

Rosemont students or staff may copy their own material if necessary.

Archives and Special Collections

Scans of materials must abide by all copyright restrictions. GKML will provide scans for educational purposes for classrooms permitting staff time and availability. The archives and special collections will not copy more than 10% of a work or collection for classroom or personal purposes.

GKML will provide scans for official Rosemont College publications assuming the image(s) abide by copyright and donor restrictions.

GKML staff are solely responsible for scanning archival material with exceptions being made at the discretion of the GKML staff.

External Use

Use of the Archives' images, audio, and video materials for **publication, commercial use, or distribution requires written permission and licensing** from the Archives. Licensing for some materials may also require approval of Rosemont College Office of Institutional Advancement. Associated fees may apply.

Scans of material for personal and educational purposes are permitted by contacting GKML staff. Archives and Special Collections will not copy more than 10% of a work or collection. Associated fees may apply.

Terms and Conditions:

1. U.S. Copyright law (Title 17, U.S. Code) protects creators' rights to control the use of their works for a limited period of time. Creators have exclusive rights to reproduce, distribute, perform, and display their works, and to create derivative works. In addition to copyright protections, some materials may be subject to restrictions because of privacy and publicity rights, trademark, purchase agreement, or donor stipulation.
