



# CAMPUS SECURITY AUTHORITY INCIDENT REPORT FORM

**Form Instruction:**

1. Report any crime that you observe, become aware of, or is reported to you by a victim, perpetrator, witness or third party.
2. Please report the incident in a timely manner. The information you provide is important for documentation of the crime as well as duplicate report comparison and may be evaluated for a campus crime alert.
4. The location of the crime and type of crime are the two factors which determine if the incident can be counted as a Clery statistic.
5. Third party reports of crimes are Clery-reportable, if you believe the information is provided in good faith (not rumor or hearsay).
6. No RC affiliation of the victim or reporting party is necessary for the crime to be reported to you and counted as a Clery statistic.
7. If you are unsure how to classify a crime, or if a crime occurred, please be sure to provide specific incident details and the Rosemont College Public Safety Department will use these details to evaluate and appropriately classify the crime.
8. Attempted crimes are Clery-reportable.
9. Report all incidents motivated by bias, regardless of the type of crime that occurred.
10. The victim or reporting party is not required to contact law enforcement and no investigation of the crime is required.
11. Encourage the victim or reporting party to report the incident to the Rosemont College Public Safety Department at 610-527-1038.

**Select the category that best fits the description of the crime you are reporting (If you are unable to determine the crime, describe the incident in detail (above)).**

- Murder and Non-Negligent Manslaughter:** the willful (non-negligent) killing of one human being by another.
- Negligent Manslaughter:** the killing of another person through gross negligence.
- Robbery:** the taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.
- Aggravated Assault:** an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.
- Burglary:** the unlawful entry of a structure to commit a felony or a theft.
- Motor Vehicle Theft:** the theft or attempted theft of a motor vehicle.
- Arson:** any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling, house, public building, motor vehicle or aircraft, personal property of another, etc.
- Sexual Assault (Sex Offenses):** Any sexual act directed against another person, without consent of the victim, including instances where the victim is incapable of giving consent. Include attempted Sexual Assaults, but do not include in your Clery Act statistics any Sexual Assaults other than the four types of Sexual Assaults described in this chapter.
- 1) **Rape** - is the penetration, no matter how slight, of the vagina or anus, with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. This offense includes the rape of both males and females.
  - 2) **Fondling** - is the touching of the private body parts of another person for the purpose of sexual gratification, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental incapacity.
  - 3) **Incest** - is sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.
  - 4) **Statutory Rape** - is sexual intercourse with a person who is under the statutory age of consent. In Pennsylvania, the age of consent is considered any person who is under the age of 16 and who has intercourse with a person who is four or more years older than the victim.
- Domestic Violence:** a felony or misdemeanor crime of violence committed by:
- 1) a current or former spouse or intimate partner of the victim or
  - 2) a person with whom the victim shares a child in common or
  - 3) a person who is cohabitating with or has cohabitated with the victim as a spouse or intimate partner or
  - 4) a person similarly situated to a spouse of the victim under the domestic or family violence laws of the Commonwealth of Pennsylvania or
  - 5) any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the Commonwealth of Pennsylvania.
- Dating Violence:** violence committed by a person:
- 1) who is or has been in a social relationship of a romantic or intimate nature with the victim and
  - 2) where the existence of such a relationship shall be based on the reporting party's statement and with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship.
- Stalking:** engaging in a course of conduct directed at a specific person that would cause a reasonable person to:
- 1) fear for his or her safety or the safety of others or
  - 2) suffer substantial emotional distress.
- Arrests and Referrals for Disciplinary Action:** include the following:
- Carrying/Possessing Weapons (unlawful use of weapon, carry concealed weapon, possess restricted weapon)
- Arrest                       Disciplinary Referral
- Drug Law Violations (possession or distribution of a controlled substance)
- Arrest                       Disciplinary Referral
- Liquor Law Violations (under age possession or consumption, furnishing liquor to minor)
- Arrest                       Disciplinary Referral

**If the crime was motivated by bias (see below), you may select one of these categories for reporting purposes.**

**Bias** is defined as a preformed negative opinion or attitude toward a group of persons based on their race, gender, religion, disability, sexual orientation, gender identity ethnicity or national origin.

**Hate Crimes:** include any of the above mentioned criminal offenses and any incidents of larceny-theft, simple assault, intimidation, destruction/damage/vandalism of property or of other crimes involving bodily injury to any person that are motivated by the offender's bias.

**Please identify the bias.**

- Race.** A preformed negative attitude toward a group of persons who possess common physical characteristics (e.g., color of skin, eyes, and/or hair; facial features, etc.) genetically transmitted by descent and heredity which distinguish them as a distinct division of humankind (e.g., Asians, blacks, whites).
- Gender.** A preformed negative opinion or attitude toward a group of persons because those persons are male or female.
- Religion.** A preformed negative opinion or attitude toward a group of persons who share the same religious beliefs regarding the origin and purpose of the universe and the existence or nonexistence of a supreme being (e.g., Catholics, Jews, Protestants, atheists).
- Sexual orientation.** A preformed negative opinion or attitude toward a group of persons based on their sexual attraction toward, and responsiveness to, members of their own sex or members of the opposite sex (e.g., gays, lesbians, heterosexuals).
- Ethnicity/national origin.** A preformed negative opinion or attitude toward a group of persons of the same race or national origin who share common or similar traits, languages, customs and traditions (e.g., Arabs, Hispanics).
- Disability.** A preformed negative opinion or attitude toward a group of persons based on their physical or mental impairments/challenges, whether such disability is temporary or permanent, congenital or acquired by heredity, accident, injury, advanced age or illness.

**In addition, the following crimes are also considered hate crimes when motivated in whole or in part by the offenders bias against one of the groups names above.**

**Larceny-Theft:** The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. Constructive possession is the condition in which a person does not have physical custody or possession but is in a position to exercise dominion or control over a thing.

**Simple Assault:** The unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

**Intimidation:** Unlawfully placing another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

**Destruction/Damage/Vandalism of Property:** Willfully or maliciously destroying, damaging, defacing, or otherwise injuring real or personal property without the consent of the owner or the person having custody or control over it.
